LEGAL AWARENESS

Legal awareness means , having know how about general legalities, which are necessary for living in society. Legal awareness helps not only in mending out legal ways for doing our work, but, also helps us in getting aware about rules and regulations formed for our benefit. We identified the need of lack of basic legal knowledge in Lucknow district, so we decided to have a camp there on May 23, 2018.

Our camp was organized in order to impart people with legal know how to make their regular life easier, and in order to remove misconceptions prevailing in them regarding government policies and working.





This camp was focused on eradicating two basic problems related to less knowledge regarding legalities:

• Women maintenance:

Through the

camp, women were made aware regarding laws & technicalities about divorce, how they can tackle this issue easily and what divorce laws are made for benefit of women, like women maintenance allowance, most of the women are unaware about this were also informed about Divorce laws and maintenance allowance that women should get in case of a divorce.

• Legal Remedies Primafrio:

Most of the people don't have any idea about general legal facts and issues, like how to do an FIR, what points should be considered in it, how to track status of it, and what to do in case if it is not registered, how to file an affidavit, etc. Our camp provided people with knowledge about basic legalities, in an process to make their life more easier, and make them less susceptible to frauds, misinforming etc.





<u>ENVIRONMENTAL</u> <u>AWARENESS</u>

Environmentalism is an ideology that evokes the **necessity** and responsibility of humans to **Environmental awareness** proves important for several reasons; it fosters a sense of connection to the natural world, promotes sustainable development and encourages conservation of irreplaceable natural resources and vulnerable plant and animal species.

We all have to contribute to it, not only the government. But if we first start thinking about our convenience and the environment for any action that we do probably it will help. So the change has to come in the way people start thinking about it.



- Reduce, Reuse and Recycle the three R's
- Use as far as possible locally produced groceries, goods and services.
- Make each community as self-supporting as possible.

This awareness camp held on August 12, 2018 informed people about habits & practices that they should include in their lifestyles to support the environment. We encouraged people to plant trees to maintain greenery and taught them ways to recycle wastage as to reduce carbon footprint. People were taught ways to do water conservation & harvesting and were also explained its benefits.





MEDICAL AWARENESS

In order to create health awareness, it is important to understand what it entails. It is the process of enabling people to increase control over, and to improve their health. This essentially means to reach a state of complete physical, mental and social well-being. The community needs to realise a desire to satisfy needs and to adapt to the environment.

Healthier eating and regular exercise increases health and productivity. There is also a decrease in absences in the workplace which in turn boosts the economy.

A healthier lifestyle and environment increases general optimism and contentment.

Some areas in shikohabad & Firozabad district are very less aware about the medical facilities provided by the govt., and how to take benefit of them. So, we organized a camp on Nov 14, 2018 for serving this purpose, where we informed people about medical facilities govt. provide. We educated people to remove misconceptions about having vaccination, and explained them why it is necessary. We encouraged people to have healthy habits to avoid problems like anaemia, thyroid, filaria, Low BP, Sugar etc. We promoted use of iron tablets, iodine salt for avoiding these sorts of problem. We also promoted people to include healthy habits in their daily life to avoid regular health problems. We imparted knowledge about facts they should check in case of an any epidemic in their area, and what general symptoms they should notice in case of any disease. And after that what steps should be taken till the medical facilities can't be reached so that duration for positive curing of disease can be increased further.





DIGITAL LITERACY AWARENESS

We initiated our operations in Lucknow, conducting awareness camps to help people recognize importance of education in their lives and for society. We partnered with local educational bodies to conduct special classes for children and adults. We have witnessed growth of literacy rate from 69.18% in 2004-2005 to 77.29% in 2018-2019 in our operation areas. With the increase in our operation base, we have started literacy programs in Shikohabad district from 2017-2018.

We organized a Digital Literacy Camp of 15 days in Feb 2019 in Mirzapur District, teaching people the basic knowhow of upcoming advancements in digital technology. We provided people with opportunity to become familiar with usage of computers and internet in their work, through courses that we have formulated with educational bodies. Over 235 people were benefitted by this camp; short courses were conducted on basic computer operation to make people aware about new technology. They were also introduced to internet services like account opening, and other govt. schemes.
